### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY ("AGREEMENT")

<p>IN CONSIDERATION of being permitted to participate in any way in Simsbury Camera Club (SCC) sponsored activities that may take place from time to time (the "Activities"), I for myself, my personal representatives, assigns, heirs and next of kin:</p> <p>1. Acknowledge, agree and represent that I understand the nature of the Activities and that I am qualified, in good health and in proper physical condition to participate in such Activities. I further acknowledge that the Activities may involve certain hazards. I further agree and warrant that if at any time I believe the conditions to be unsafe. I will immediately discontinue further participation in the Activities. Participation in the Activities is entirely voluntary.</p> <p>2. Fully understand that (a) the Activities may involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death, and also involves risk of damage, theft or loss to equipment ("Risks"); (b) these risks and dangers may be caused by my own actions or inactions or the actions or inactions of others participating in the Activities, the condition in which the Activities take place, or the negligence of the "Releasees" named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and responsibility for losses, costs and damages incurred as a result of my participation in the Activities.</p> <p>3. Agree that images shared with SCC may be published in club-related media. This may include the following: digital projection, internet publication, contest entry or other forms. Electronically and physically shared images may be vulnerable to harm or piracy. I agree that SCC is not responsible for any unauthorized use of images, or litigation that may result from such use and I expressly waive any claims that I may have against the "Releasees" named below arising out of or in connection with such use of images.</p> <p>4. HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE SCC OR ANY OF ITS AFFILIATES, AND THEIR RESPECTIVE AGENTS, REPRESENTATIVES, VOLUNTEERS, ADMINISTRATORS, AND OFFICERS (THE "RELEASEES") FROM ALL LIABILITY, CLAIMS, DEMANDS, ACTIONS AND CAUSES OF ACTION WHATSOEVER ARISING OUT OF OR RELATED TO ANY LOSS, DAMAGE OR INJURY, INCLUDING</p>	<p>5. DEATH. THAT I MAY SUSTAIN. OR TO ANY PROPERTY BELONGING TO ME. WHETHER CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, WHILE PARTICIPATING IN THE ACTIVITIES, OR WHILE IN, OR UPON THE PREMISES WHERE THE ACTIVITIES ARE BEING CONDUCTED. I FURTHER AGREE THAT IF, DESPITE THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, I OR ANYONE ON MY BEHALF, MAKES A CLAIM AGAINST ANY OF THE RELEASEES. I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS, LIABILITY DAMAGE, OR COST WHICH THEY MAY INCUR AS THE RESULT OF ANY AND ALL CLAIMS. IT IS MY EXPRESS INTENT THAT THIS RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT SHALL BIND THE MEMBERS OF MY FAMILY AND SPOUSE. IF I AM ALIVE, AND MY HEIRS, ASSIGNS AND PERSONAL REPRESENTATIVES. IF I AM DECEASED, AND SHALL BE DEEMED AS A RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE THE ABOVE-NAMED RELEASEES. I HEREBY FURTHER AGREE THAT THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CONNECTICUT.</p> <p>5.1 agree to engage in the SCC and any of its programs or events, including the Activities, in a reasonable fashion and not to act negligently or engage in misconduct while participating in the Activities. I understand that I will be responsible for damages that may be incurred by SCC and any other participants in the Activities that may arise out of my negligence or misconduct.</p> <p>IN SIGNING THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing, fully understand its terms, understand that I have given up substantial rights by signing it; I am at least eighteen (18) years of age and fully competent to sign this Agreement; and I have signed this Agreement freely and without inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.</p>
